Monthly Meeting Minutes

Supervisor Barbara Klasen called the monthly meeting of Greenwood Township Board of Trustees to order at 7:36 pm followed by the Pledge of Allegiance.

Board Members Present: Trustee Tim Stefaniak, Trustee Christopher Dahm , Trustee Karin Swencki, and Trustee Charles Beard .

Other Members Present: Highway Commissioner Don Goad, Bookkeeper Colleen Dumais, Supervisor Barb Klasen, Deputy Assessor Randall Roth, and Clerk Kendra Rishling.

Approval of Minutes: Motion made by Charles Beard to approve the minutes from April 19th, 2010. Seconded by Christopher Dahm and motion carried.

Approval of Township and Road District Bills: Motion to approve the Township and Road District Bills by Tim Stefaniak and seconded by Christopher Dahm. By roll call vote, all in favor said aye. Motion Carried.

Assessor's Report: Deputy Assessor Randall Roth reassessments are started and they are looking at newer neighborhoods. Looking for trends in foreclosures and how it will impact assessments.

Audience Questions/Comments: No questions.

New Business: Cheryl Hammerand from the Greenwood Handi-helpers presented the President and Vice president of the club to the Board. Cheryl wanted to let Board know the fees will remain the same for new members and she is anticipating about 200 dollars in new membership fees. Cheryl is requesting donations from Board. The membership year starts September 1st and ends August 31st. Board agrees and wishes to be stated in the minutes that tax payer dollars will not be used for donations to any club

or organization but Dahm Enterprises will donate and Highway Commissioner Don Goad says he will donate some of the money from the sale of any scrap metal accumulated from the Township.

Old Business: Jon Toussaint not present.

Township Budget Hearing to be set for 7:00 pm and Road District Budget Hearing at 7:15 pm on June 21st, 2010.

Christopher Dahm motioned to set date and time as stated above. Charles Beard seconded. All in favor said aye.

Supervisor's Report: Supervisor Barb Klasen stated she would like noted in the minutes that the transfer of the money from the Road District to the Township did occur for the 30,000 dollars for covering expenses until the end of budget to avoid any loans outside of the Township. It will be repaid in new budget back to Road District.

A secure Network for the Township will be established so the computers can be accessed outside of the office area. Each office will also have wireless routers.

New application was submitted for membership on the Planning Commission Board. If applicant excepted this will decrease the vacancies to one.

Road Commissioner's Report: Highway Commissioner Don Goad stated that roads are being prepped for paving and that they are trimming trees.

Bookkeeper's Report: Bookkeeper Colleen Dumais Health Insurance Percentage decreased from 19% to 7 %.

Adjournment: Motion to adjourn the monthly Board meeting by Tim Stefaniak and seconded by Christopher Dahm. Motion carried. Meeting adjourned at 8:05 pm.
