**Greenwood Township Board of Trustees**

**Monthly Meeting Minutes**

**May 16, 2011**

Supervisor Barbara Klasen called the monthly meeting of the Greenwood Township Board of Trustees to order at 7:40pm followed by the Pledge of Allegiance.

**Board Members Present:** Trustee Tim Stefaniak, , Trustee Karin Swencki, and Trustee Charles Beard .

**Other Members Present:** Supervisor Barb Klasen, Highway, Commissioner Don Goad, Deputy Assessor Randall Roth, Bookkeeper Colleen Dumais.

**Approval of Meeting Minutes:** Tim Stefaniak motioned and Charles Beard seconded to approve the monthly meeting minutes for April 18, 2011.

**Approval of Township and Road District Bills:** Motion to approve the Township and Road District Bills by Tim Stefaniak and seconded by Karin Swencki. By roll call vote, all in favor said aye. Motion Carried.

**Assessor's Report:** Deputy Assessor Randall Roth reviewed with the Board in the absence of Assessor Karen Roth that tax bills are out and they expect the phone calls to start. B. Klasen suggested putting a statement on line which Randy said he is working on. He reviewed the reasons for the State multiplier that was placed on this year's tax bill for one year only. Last year multiplier was .9463, this year the State multiplier is 1.0348.

Colleen Dumais suggested maybe now would be a good time to hold an informational meeting to explain the assessment and taxing system. Will discuss next month to see if there is a need.

**New Business:** Supervisor B. Klasen reviewed the proposed budget and set hearing date of for June 20<sup>th</sup> at 7:00 for budget hearings for township and road district.

**Supervisor's Report:** Supervisor Barb Klasen advised the Board we received a notice that the property at 9505 Thompson is petitioning to annex into the Village of Bull Valley.

**Road Commissioner's Report:** Highway Commissioner Don Goad is buying tires for trucks and can save \$40 per tire on state bid if he buys all of them at once.

Purchased used boom mower in good condition for \$20,000, price for a new one would be \$80,000 to \$100,000.

Needs to patch Jankowski Rd. Bridge. Materials will cost approximately \$3,000 and they will do the labor themselves.

T. Steffaniak asked Don if he was compiling a report on all the township roads. Don said he was working on this and would have report complete in the fall.

Don also advised they will patch a portion of Howe Rd.

D. Goad will be placing equipment on list previously presented at annual meeting up for bid.
